After another day of work in subgroups the following future plans of WG2 were presented in the final plenary session:

## **Subgroup 1 on Moral Theory and Disasters (Deputy chair: Vasil Gluchman)**

Supgroup 1 starts cooperating with sub-group 2 (on the Concept of Disaster). Plans are to come up with a clear concept of disaster and use it as starting point for analysing approaches of moral theories to disaster issues.

The next activity will be announcement of CFA focused on moral theory and disaster issues (after approval by Steering Committee) for the workshop organized on the next spring in Prešov (Slovakia), selection process and invitation for participation on workshop to other persons outside of the sub-group. The subgroup will organize the workshop on Moral Theory and Disaster Issues in Eastern Slovakia in April or May 2015. The final step will be preparing a project for publishing workshop papers in edited volume or within special issue of journal. Furthermore, there will be also activities joined with participation of the international conferences, preparing final version of papers, etc

### Subgroup 2 on Disasters (Chair: Joanna Rozynska filling in for Vilius Dranseika)

Apart from the start of cooperating with subgroup 1 (on Moral Theory) Vilius Dranseika and Joanna Rozynska are continuing their research on anthropomorhism in conceptualizing disasters. Studies are expected to result in a peer-reviewed journal article.



## **Subgroup 3 on Action Guiding Algorithms (Chair: Emanuele Valenti)**

Elaboration of the research project on Coercion in Disaster medicine (presented in Porto) to discuss critical appraisals in order to improve the protocol. Research will produce a main paper and a secondary study with another paper.

## Subgroup 4 on Culture, Cultural Disagreement & gender (Chair: Ayesha Ahmad)

Subgroup 4 is planning a workshop that address aspects of culture and gender in disaster situations Contributors from the workshop will be included in an edited volume, which will be edited by members of the subgroup.
